<u>From the north</u> Take I-55 [SR-121] to I-270. Follow I-270 for 23.6 miles. At exit 26A, take Ramp (right) onto I-170 for 4.4 miles. At exit 6, turn right onto Ramp. Turn left (north-west) onto SR-115 [Natural Bridge Road].

<u>From the east</u> Take I-70 to I-57 [I-70]. I-70 changes names to I-270. At exit 26A, take Ramp (right) onto I-170 for 4.4 miles. At exit 6, turn right onto Ramp. Turn left (north-west) onto SR-115 [Natural Bridge Road].
