Please park in the Concourse Hotel parking ramp, which is on site and below ground. The entrance is immediately on your left on Dayton Street just past Wisconsin Avenue. Parking is complimentary for hotel guests.

Directions from Iowa

Highway 151 North connects with the Beltline Highway in Madison. Follow Highway 151 to exit 261 (Park Street).

Travel Park Street for approximately 3 miles to Johnson Street and turn right.

Travel Johnson Street for approximately 8 blocks to Wisconsin Avenue and turn right.

Travel 1 block on Wisconsin Avenue and turn right onto Dayton Street. The hotel is to your left.

Directions from Chicago

Take exit 142A from Interstate 90. This is WI State 12/18 West.

Travel WI State 12/18 west for approximately 4 miles.

Take exit 263 (John Nolen Drive) for approximately 2 miles.

Turn left onto Broom Street and travel approximately 7 blocks.

Turn right on Johnson street and travel approximately 3 blocks.

Turn right onto Wisconsin Avenue and travel 1 block to Dayton Street. Turn right onto Dayton Street and the hotel will be on your left.

Directions from LaCrosse and Minneapolis

Take Exit 135A from Interstate 90/94. This is 151 South (East Washington Avenue).

Travel East Washington Avenue straight up to the state capitol building.

Turn right one block before the capitol on Webster Street.

Travel Webster Street for two blocks and turn left on Dayton Street.

Travel Dayton Street for two blocks. The hotel will be on your left.
