- Missouri operates under a state fiscal year budget. They have obligated by check the 2005 funds and will obligate for 2006 using SPR funds in August 2005.
- Ohio also operates on a state fiscal year.
- Wisconsin operates on a federal fiscal year budget running October 1 September 30.
- Michigan has agreed to apply funds that they had obligated to the Winter Concept Vehicle pooled fund project (#SPR-3(066)) to Clear Roads projects related to snow plow technology. This amount represents Michigan's 2005 membership fees for Clear Roads
